### **WHAT IS A PEDIATRIC NURSE PRACTITIONER?**

A Pediatric Nurse Practitioner is a registered nurse with advanced education (usually a Master's degree) who has been trained in providing health care to children. He/she has received training in the diagnosis and treatment of illnesses common to pediatrics. Nurse Practitioners are knowledgeable of normal growth and development in children. This is extremely important in assessing the needs of children and providing counseling to the parents.

Nurse Practitioners are recognized as health care providers and can provide primary care as well as treat illness. Their license allows them to write prescriptions, thus providing complete care to their patients. They are eligible to sit for board certification as a Pediatric Nurse Practitioner by the National Certification Board of Pediatric Nurse Practitioners and the American Nurses Association.

### **ABOUT OUR STAFF**

Our nurses, are overseen by our Nursing Director Elizabeth Moore. Our nurses perform such duties as taking temperatures and blood pressures or doing blood tests in preparation for the doctor's visit. Our medical assistants assist the nurses in setting up your visits with the doctor, completing school forms and organizing medical information.

Our front office staff answers the telephones, takes messages, schedules appointments and assist you at checkout.

Our Referral Coordinator, is there to assist you when you need a referral to another physician and to obtain preapproval for testing or equipment that your child may need.

Our Insurance Coordinators, work with our contracted insurance carriers. They are responsible for submitting claims to your insurance company, keeping up to date with the changes that these companies make and making sure we are in compliance. Maria DeMaria is responsible for patient payments and is available to help you set up a payment plan if needed. You can contact them at 203-798-7661 with any billing question you might have.

Of course we are available after hours and on weekends. Our doctors can be reached anytime after hours for emergencies through our answering service; just dial our office number and an operator will assist you. Our office staff will be in at 8:00 a.m., Monday through Saturday, to return your call.

Please note that an after hours fee may be charged on weekends and for office visits scheduled after our normal closing time.

### **TELEPHONE CALLS**

Questions are welcome by phone. A triage nurse is available during our office hours to answer your medical questions. If there is a high volume of calls, the nurse will prioritize the calls and get back to you and soon as he/she can.

There are times when the phones are turned over to our answering service during lunch for staff meetings. In the New Fairfield office, the telephones are turned over to either the Danbury office or the answering service from approximately 12:15 pm until 1:15 pm to give the staff an opportunity to have lunch and follow-up with patients. After office hours, we use a pediatric nurse triage line where your questions will be answered promptly, 24/7. Please be assured, however, that our doctors remain available for priority calls at all times.

### **REFERRALS**

Many insurance plans request that you obtain a referral before visiting a specialist, or preauthorization for testing and x-rays. Our Referral Coordinator, can be reached at 203-790-0822 and will be happy to assist you in this process. We ask that you give our referral coordinator at least 3 days advance notice if you need a non-urgent referral.

### **Patient Portal**

Our Patient Portal is a secure online website that allows patients and parents the ability to access personal health information and to gain access to online billing features.

### **TRANSFERRING TO ANOTHER PRACTICE**

Upon written request, we will be happy to make a copy of your child's medical record to send to his new physician. There is a charge of 45¢ per page with a maximum fee of \$30 per chart. Records will be transferred within 30 days of the written request.

### **ABOUT FINANCIAL ARRANGEMENTS AND MEDICAL INSURANCE**

We are committed to providing you with the best care possible. If you have medical insurance we are anxious to help you receive your maximum allowable benefit. In order to achieve these goals, we need your assistance and your understanding of our payment policy.

#### ***Health Insurance I.D. Cards***

Please have your health insurance I.D. card available at the time of each visit. It is important that we have the correct billing information. If a claim is not received by your insurance company in a timely manner, they can deny the claim, making you responsible for payment.

#### ***Payment for Services***

Payment for services and/or copays are required and expected at the time of your appointment. Patients who are not prepared to make their copayment at the time of their appointment will be charged a \$10 administrative fee. There will be a \$20.00 fee for returned checks and we reserve the right to request payment in the form of cash or credit card for all future payments.

#### ***Payment for Forms***

A fee is charged for each form (school, camp, and daycare).

#### ***Patient Balances***

The Center for Pediatric Medicine expects payment on patient balances within 30 days of service. If you cannot pay your balance within 30 days we encourage you to contact Maria DeMaria, our Patient Representative, for assistance in the management of your account. Maria can be reached at 203-798-7661.

#### ***Missed Appointments***

As a courtesy, our front desk staff will call you and confirm your appointment. Since their efforts are not always successful, we ask that you note your upcoming appointments on your calendar.

Unless cancelled, at least 24 hours in advance, **our policy is to charge for missed appointments.** Please help us serve you better by keeping scheduled appointments.

#### ***Please be aware that . . .***

Your insurance is a contract between you, your employer and the insurance company. We are not a party to that contract.

Not all services are a covered benefit in all contracts. Some insurance companies arbitrarily select certain services they will not cover. While we make the best effort to understand the benefits of your insurance plan, *it is your responsibility* to distinguish services that are covered from those that are not covered. For example, is your child's physician a participating provider with your insurance company? If bloodwork is needed following an office visit, can it be performed at the doctor's office or should you go to a laboratory approved by your insurance company? If your child needs to see a

specialist, do you need to obtain a referral from your primary care provider? Are you required to make a copay for a well examination? Please take the time to become familiar with your insurance coverage, as it will benefit only you.

### ***BILLING AND INSURANCE – FREQUENTLY ASKED QUESTIONS***

**Q: If my insurance company pays for my baby's claims the first 30 days of life, does that mean my baby's insurance enrollment is complete?**

A: *NO.* Most insurance companies will pay newborn claims for the first 30 days under the parent's policy. During this 30 days period, you must contact your employer, or your insurance company, to add your baby onto your policy.

**Q: Both Mom and Dad have different insurance plans but the baby will be enrolled in only one of them. Does the pediatrician need to have both parents' insurance information?**

A: *YES.* Most insurance companies pay under the parent's policy for the first 30 days, even if you decide not to enroll the child under your policy when the 30 days period has ended. During this time the child is covered under BOTH parents' policies, so the pediatrician will require information for both plans.

**Q: If I get a bill and I know my pediatrician's office has my insurance information, should I call the billing office? I know it takes a while for insurance companies to process claims.**

A: *YES.* Always call our billing office at 203-798-7661 when you get a bill that you believe your insurance should cover. Many insurance companies require you to call every year to update your coordination of benefits, or they may need other information in order to process your claim. Our staff will assist you in navigating your insurance, when possible. Please note that most insurance companies give up to 3 months from the date of service to correct a problem. If the billing problem is not corrected in this 3 month period, the insurance company has the right to refuse payment, making the balance your responsibility.

**Q: If my child has State Husky insurance and I get a bill, should I be concerned since the state insurance will cover 100% of my claims (except for the \$10 copay for the Husky B Plan).**

A: *YES.* Always call our billing office when you get a bill. In many instances, the state has wrong information, such as date of birth, a misspelling of your name, or their records show the child is also covered under a commercial insurance that is no longer active. Our billing staff can help you identify the problem so that you can contact your caseworker to correct the error in order to get the claim paid.

**Q: If the front desk does not ask me for a copayment at the time of my child's visit, does that mean I don't have a copay?**

A: NO. It is not always clearly stated on your insurance card if there is a copayment due for a sick visit, well visit, or both. It is YOUR responsibility to know when a copayment is due. Please assist our front desk staff by making your copayment at the time of the office visit. Please be aware that, if you DO NOT pay your copay at the time of service, we will send you a bill with an additional \$10 processing fee added to your account.

**Q: Can I assume that I will not incur any charges for a well visit since my insurance policy states well visits are 100% covered?**

A: NO. The physician's examination of your child is a covered benefit. However, there are many tests, procedures and questionnaires performed at well visits that your insurance may not cover. In many instances, insurance companies are no longer covering in full for urinalysis, hearing screen, eye tests and blood tests. If you have separate vision coverage, or your child sees an eye specialist, please let our nurses know so we don't duplicate services.

### **RECOMMENDED WELL VISIT SCHEDULE**

The CPM Family understands that every family is different. We offer two well visit schedules for your infant during their first year; monthly well checks or the more traditional every other month schedule. Those who choose to come in monthly have the opportunity to discuss their concerns more frequently, and are often preferred by new parents. The 1 month and 7 month exams and 8 month nutrition consult are billed to the insurance company as OFFICE VISITS, and are not generally covered.

## **Well Visit Schedule**

Parents/guardians are to accompany all children under the age of 18 to their well visits, however, after initially discussing the teen's health with the

family, the parent(s) are asked to leave the room to give the teen privacy during the exam portion.

## Birth - 2 1/2 Years
